Motion to Adopt Meeting Minutes from August 22, 2024

Motion to Separate Contract Item no. 6 into Resolution 2

Motion to Table Resolution 2 until October 30, 2024 Meeting

Vice Chairperson, Dr. Angela Green, made a motion to table Resolution 2. Motion was seconded by Panel Member Giordano. Motion to Adopt Resolution 1

Chair Faulkner made a motion to adopt Resolution 1 (containing contract items 1-5 and 7-15). Contract items were approved as follows:

Motion to Adopt Resolution 2

Chair Faulkner made a motion to adopt Resolution 2 (containing contract item 6). Motion failed unanimously 0-20-0 (nay: Ali, Alicea, Aubin, Bogad, Casaretti, Dienstag, Fair, Faulkner, Garcia, Giordano, Green, Hasan, Ho, Lee, Odwin, Ong, Sapp, Sheppard, Sze-Tsang). There were no recusals.

Approval of Bylaws Review

It was recommended that the Bylaw amendments be considered in a single item titled Resolution 1.

Motion to Adopt the Annual Bylaws Review
